PHYSICAL DISABILITY

LOSS OF COMMERCIAL DRIVER'S LICENSE

Your failure of a Department of Transportation physical examination or an accumulation of points on Your Commercial license due to: (1) driving while disqualified; (2) excessive speeding; (3) failure to keep right; (4) failure/improper signal; (5) following too close: (6) improper lane; (7) no insurance; (8) similar traffic offenses.

SELF-EMPLOYED PERSONAL BANKRUPTCY

You file for personal bankruptcy and are an individual owning and operating a business, alone or in partnership with one or more persons.

Your death is caused by external trauma, from a force foreign to You, and not arising out of or due to disease or illness.

INVOLUNTARY UNEMPLOYMENT OF SPOUSE

Your Spouse suffers a total loss of salary or wages for a period of at least 45 consecutive days as the result of the loss of non-seasonal or temporary employment and qualifies for state unemployment benefits.
